# Introduction - What's with Jake and Elwood?

We're both Gen-Xers who grew up with 1980s and 1990s comedy: Saturday Night Live, Blues Brothers.

We both try to keep a sense of humor while working with very grim material. There are a lot of absurd elements.

Jessica lives in Chicago area - where Blues Brothers story takes place.

Katherine lives in central Pennsylvania.

# Series of events that led to video discussion

- Katherine read Jessica's work on Twitter under Jessica's Emma Woodhouse handle 2020-2021, until Twitter stopped letting people read unless they registered as platform users.
- Later we were both publishing our work on Substack.
- Within the last year or two, we engaged in public dialog on some subjects - JH proposed questions, KW replied, JH responded, we published our discussions on our Substacks.
- We both left Substack in late 2025
- After we were both off Substack, JH initiated email correspondence, suggested meeting in Pittsburgh in person to compare notes. We met in Pittsburgh for a couple of days in January 2026.
- A couple of weeks ago as the "hantavirus" performances began, KW asked JH "do you see value" in the two of us doing a joint video discussion about what we learned after 2020 that might be of use to people navigating current events? JH said yes, let's do that.
- We drafted joint presentation deck and recorded the discussion.
- Format – cross between a conversation between two colleague and a tutorial

# Central area of agreement

We don't have the exact same views of all issues.

Our **main shared position** is that **“natural outbreak” narratives pitted against “gain-of-function” and “lab leak” narratives present a false dichotomy** to skip the public past the more foundational issues:

Did something, anything, new and deadly, “break out” or “emerge and start spreading” in late 2019-early 2020 **at all** (the story told about the coronavirus pandemic). Is such a phenomenon even physically possible? Has it happened previously? Could it happen again?

Both concluded (after following different paths) that **no “outbreak” or “spread” of anything other than false, fear-inducing information, occurred in 2019-2020 for coronavirus**, and it's not physically possible in general, at all.

No need for anyone to be afraid of sudden outbreaks or spread events, then or now.

**The threat governments publicized in 2020 was not a true physical threat. It was an illusion projected mostly by means of staged photos, false scientific papers, false diagnostic tests, false infection and death data dashboards and false news reports based on those false photos, papers, tests and data sets.**

Same methods being used currently for hantavirus and other putative pathogens.

**Understanding how the illusions are projected can help people navigate current events with less fear and more confidence.**

# Goals

Offer some information to support at-home, family preparation to resist any and all onslaught of pandemic-pathogen-spread fiction

- Science fiction
- Data fabrication, distortion, manipulation
- Unjust law
- Gov't-corp-media advertising/marketing/PR campaigns

**Hockett: “All it takes is a story, a test, and plenty of propaganda.”**



## Current Event Catalyst: Hantavirus “Outbreak”

# Intended Audience

- People who are trying to maintain their composure and equanimity, understand the world in a calm, reasonable way, and have at least a suspicion that the narratives presented by governments, corporations and media PR channels, about hantavirus and about similar phenomena, are not quite aligned with reality.
- **Not** people who enjoy being frightened of imaginary things, horror movies, ghost stories, etc.

that prepared each of us

to be skeptical about government-corporate-  
media panic-monger stories

and

to do the work that we've each done.

# Hockett

- Naturally skeptical and “oppositional”
- Parents modeled being critical. Family dynamics encouraged & favored debating issues and questions. Immediate & extended family occupations involved news media, entertainment, hospitality, & healthcare.
- Christian high school emphasized *worldview* and understanding & engaging others’ worldviews. Academic training conditioned hyper-focus/deep study of a phenomenon.
- Education-sector work and publications involved trying to change people’s minds and actions in a system (district, school, classroom)
- 2018-early 2020, publicly involved with “exposure” of corruption in former church; publicly speaking against certain initiatives & activities in local public school system
- MD sister involved in localized Lassa Fever and Ebola events in Africa.
- Few “sacred cows” – will entertain speculative or serious discussion of almost anything as being a staged, planned, constructed, or leveraged event.

# Watt

Introverted, observant (anomaly and pattern recognition), analytical temperament

Traditional Catholic family: formation of conscience, distinction between truth and error, right and wrong, justice and injustice

Studied philosophy and natural sciences (bio, chem, physics) in college

Newspaper reporter work: interviews, research, fact-checking, journalistic integrity, investigation of government and corporate corruption

Paralegal work: document review, legal research, evidence assessment, argument construction, assembly of supporting documents, legal writing

Daughter, sister, wife, mother: observant of chronic health disorders across several generations of family and friends.

# Watt: Subjects of Investigation

## Watt

Collation and analysis of law records (statutes, regulations, etc.) authorizing presentation of fabricated or distorted events and responses as real and proportional: false justification for public policy responses, joint government-corporate-media deployment of false devices (diagnostic tests) and false treatment and prevention protocols, products (masks, drugs, vaccines). Collation and analysis of historical scientific/biomedical research fabrication and distortion records. (work-in-progress)

# Hockett: Subjects of Investigation

## Hockett

Collation and analysis of evidence (statistical data on infections, spread, morbidity, mortality) demonstrating how governments and corporations present fictional events that the laws are constructed to allow them to present.

Evaluation of actors, scenes, and storylines conveyed through the events.

Analysis of how the State-Sponsored Narrative (Offensive) and forms of Permitted Dissent (Counter-Offensive) protect core lies and sideline Off-Limits views (No-Fly Zones), esp. with respect to spreading disease-causing viruses.

# How Hockett & Watt work converges

## Two Knowledge Sets, One Target

- **Watt**  
Law, U.S. history, vaccination programs, biological/chemical/medical science
- **Hockett**  
Data, social science/psychology, operations, finance/fraud, media/political theatre
- **Shared:**  
Journalism, documentation, archiving, natural law/theology
- **Together:**  
We cover legal, scientific, historical, operational, financial, psychological, and media dimensions of the COVID event.
- **Method:**  
Preserve the record. Identify and expose contradictions/anomalies and patterns.

# Watt - Work subjects

## **Legal and historical research -**

- Original (1800s) and ongoing absence of provisions of law requiring physico-chemical evidence presentation or quality assessment to support government-corporate-media claims about causation, physical threats and response measures in communicable disease, pandemic, public health emergency contexts.
- Provisions of law authorizing legal promotion (advertising/marketing/PR) for fictitious threats, fictitious causation-attribution [framing] and fictitious response measures against fictitious threats.
- Original (1800s) and ongoing construction of scientific and biomedical mythology for communicable disease pathogens, causation, outbreaks, pandemics, vaccination.

## Main work products:

- 1) American Domestic Bioterrorism Program timeline
- 2) Legal History of Biological Product Non-Regulation (with Lydia Hazel)
- 3) St. Benedict Memo (litigation support)

# Hockett - Work subjects

**Subjects of investigation:** Testing programs; cause of death attribution; mortality, epidemiological, & vaccination data; events & episodes of late 2019/early 2020 (incl. New York City and Bergamo “death spikes”); SARS-CoV-2 origin hypotheses & storylines; COVID-19 as a multi-sided, cooperative, coordinated operation; false binaries of the COVID event and “permitted dissent” perspectives.

**Main work products:** Two longer summaries of problems with New York City mass casualty event (supported by a collection of findings based on public datasets, records, interviews, and document analysis); contributor to chapters in a book by UK statisticians; collections of individually- and co-authored articles on specific topics and episodes

# 5 Things We Each Learned Since 2020

Things we learned **after** 2020, that we would have liked to have known **before** 2020, and that are useful, applicable things to know **now**.



# Watt #5

## **Cognitive interference and behavioral conditioning**

- It's possible to be born and grow up during historical periods in which distinctions between truth and error are deliberately rendered ambiguous or obscured (cognitive interference)
- Promotion/inculcation of unjustified trust and compliance with illegitimate authority masked as legitimate authority (behavioral conditioning)
- Malicious political actors impose cognitive blindness or impairment and conditioning for malicious purposes: demoralize (induce confusion and despair), weaken, render infertile.
- The 1800s to now are such a period: mass media, “social communication,” centralized scientific research funding & publishing; instantaneous worldwide distribution of false information; chronic immersion in false reality.
- Four societal institutions for fact-finding: scientific research, journalism, courts, legislative hearings: All four distorted or blocked in disease causation arena.
- It's possible to ask God for help to see truth more clearly, thwart conditioning, expose and dispel error, encourage others. He answers such prayers.

# Hockett #5

## Foundations

The concepts which underlie and drive key questions and issues surrounding “pandemic” and disease “events” from legal, scientific/medical, and theological standpoints involve *authority*, *sickness/wellness*, and *power/control*.

- Who has authority over an individual’s body – and in what circumstances?
- What does it mean to be “sick” and “well”? Who decides? By what criteria?
- Does the State truly have the authority/power to control the body and movements of a “sick” individual? Whence the presumption of authority/power?

# Watt #4

## **Ecology & Population**

- There is no good evidence for claims of world population overshoot, food and shelter scarcity or catastrophic climate disruption.
- Evidence presented has been fabricated, distorted and published to advance a population-manipulation and power-centralization agenda of malicious political actors.

## **Hockett corroborating lesson-learned**

- Distrust of demography and population counts, including observation of shifting population data used to make unfounded claims about Covid vaccine efficacy.

# Hockett #4

## **Solution/Problem/Solution Cycle:**

### ***Vaccine-Outbreak-Testing-Vaccine...***

- Vaccines are not now and have never been what they are purported to be. (Entry points for grasping many problems with vaccine & contagion models were the flu surveillance/shot program & related studies, state and local COVID-19 vaccine data, and reading historical documents & reports.)
- Outbreaks involving transmissible viruses are contrived. They help cover-up vaccine harms/inefficacy and justify development and re-development of vaccines.
- Being tested during respiratory illness is not necessary for treating symptoms.

# Watt #3

## **Science, especially biology, subdisciplines thereof**

- Community of subvisible organisms living in and on living animals and humans is large, diverse, transient, symbiotic (non-pathogenic). Diversity, ubiquity lend themselves to mis-use to provide false/constructed support for simplistic/mechanistic narratives.
- Improved methods and equipment for extraction and observation corroborate this, confound/refute simple mechanistic explanations for health and disease causation.
- No good evidence for putative pathogens (bacteria, viruses, molecules, proteins) having stable composition or functional properties of virulence or transmissibility outside a living organism (host-to-host)
- Homeostasis, health and disease (causation, course, recovery) are irreducibly complex, multi-factorial phenomena embedded in one-directional time.
- Living creatures are alive and social, not input-output machinery and not isolated.
- Scientific publications credited as forming foundational bases for stable-&-sole-factorial disease causation (for example, Koch's postulates, derivatives) and for immunization are full of unsupported assumptions, caveats, limitations, unjustified discard of counter-evidence, equivocations, ambiguities, etc.
- Good evidence exposing these scientific myths as false, is systematically suppressed.

# Some foundational papers, scientific mythology: Attribution of disease causation by putative pathogens Attribution of disease prevention by immunization

Key concepts: Putative pathogen; correlation (association); causation; incrimination; guilt by association; obligate parasite; correlates/surrogates of disease protection; no verifiable burden of proof; no verifiable evidentiary review procedures; no feasibility

- 1840 – Jakob Henle - Von den Miasmen und Kontagien [On miasmata and contagion]
- 1884, 1890 - Robert Koch - Die Aetiologie der Tuberculose [Etiology of tuberculosis](1884); Ueber bakteriologische Forschung [About bacteriological research] (1890)
- 1898 - Martinus Beijerinck – Concerning a *contagium vivum fluidum* [contagious living fluid] as cause of the spot disease of tobacco leaves.
- 1937 – Thomas Rivers - Viruses and Koch's Postulates
- 1955 – Johannes Ipsen, Harry Bowen – Effects of Routine Immunization of Children with Triple Vaccine (Diphtheria-Tetanus-Pertussis) - “attempt to apply serologic epidemiology to interpret the past performance [effectiveness] of programs of prophylactic immunization.”

# Some foundational papers, continued

- 1957 – Robert Huebner – Criteria for Etiologic Association of Prevalent Viruses with Prevalent Diseases: The Virologist's Dilemma
- 1965 – Austin Bradford Hill – The Environment and Disease: Association or Causation?
- 1976 – Alfred Evans – Causation and Disease: The Henle-Koch Postulates Revisited
- 1988 – Stanley Falkow – Molecular Koch's Postulates applied to Microbial Pathogenicity [attribution of causation via association of genes]
- 1996 – David Relman & David Fredricks – Sequence-Based Identification of Microbial Pathogens: a Reconsideration of Koch's Postulates [attribution of causation via association of nucleic acid sequences]
- 2001 et seq Stanley Plotkin – Immunologic correlates of protection induced by vaccination (2001); Vaccines: correlates of vaccine-induced immunity (2009); Vaccines: the Fourth Century (2009); Correlates of Protection Induced by Vaccination (2010)
- 2006 – Lary Walker, Harry Levine, Mathias Jucker – Koch's Postulates and Infectious Proteins (Walker et al, 2006)

# Hockett #3

## **Data Games**

Governments and “governing” agencies engage in purposeful data construction and projection to convey illusions, advance disease-spread narratives, and perpetuate the Vaccine Solution cycle.

Epidemiological, morbidity/mortality, and vaccination data often cannot be independently verified; are easily distorted, definitionally unsound, unreliable, and/or divorced from context; lack sufficient & robust baselines; and do not acknowledge the influences of human biases & behavior & myriad psycho-social and biological factors involved in human health and disease.

**Public health data are used to control what you think about disease threats, how you behave, and how you see other human beings.**

# Watt #2

## Law

- There is good evidence that civil administrators, legislators, lawyers, judges have known since 1800s that there is no good scientific evidence supporting claims as to composition, stability, sole-cause disease-causation and transmissibility of putative pathogens (bacteria, viruses, molecules, proteins)
- Evidence: Laws (statutes, regulations, etc.) written without provisions requiring presentation or assessment of physical evidence to support scientific and biomedical claims incriminating allegedly pathogenic threats (putative pathogens)
- Evidence: Laws written without provisions requiring presentation or assessment of physical evidence to support claims about about alleged disease-control effectiveness of inoculation, vaccination, immunization

# Hockett #2

## Taxonomy and nomenclature

**Misinformation** = false information, intent not required. | **Disinformation** (Cold War Era) = false information knowingly or deliberately spread.

In the COVID Era, government has used these terms to “recode” disputed claims, interpretation, dissent, and counter-narratives as information hazards requiring monitoring, correction, suppression, removal, or prevention. **Alt:** *True information, false information, contested information, opinion, perspective*

**Anti-vax/Anti-vaxxer:** Accurate, though pejorative, terms used to characterize efforts and individuals who reject government and pharma-medical establishment claims about vaccines and vaccination.

**Alts: vaccine abolitionism, vaccine abolitionist, and vaccine abolition** are proactive, affirmative terms that name a principled effort to protect and free society and posterity from certain institutions, industries, messages, products, and acts of deceit and aggression — above and beyond efforts to resist or repeal mandates.

# Hockett #2

## **Taxonomy and nomenclature**

**Conspiracy theory:** Not “invented” by CIA/IC. Use dates to 1860s.

Generally, an explanation that attributes an event to covert coordination among interested actors. The *conspiracy* label relegates the explanation to spaces outside mainstream and permitted dissent discourse. **Alt:** *collusion theory, theory*

**Limited hangout:** deceptive, managed disclosure that attempts to function as a revelatory admission but ignores fundamental questions, distracts from underlying issues, and protects or firewalls core lies from scrutiny and keeps the full truth at bay. (Hockett/Watt) Recent example: CIA whistleblower. **Alt:** Functional “squirrel!”

# Hockett #2

## Taxonomy and nomenclature

**False flag event:** Event carried out with covert intentions that is designed to deceive or mislead. Appears to be one thing but is actually another thing. Examples: Sinking of *USS Maine*, attack on Pearl Harbor.

**Staged event:** An event that is set-up and presented in the moment or ex post facto to look like something other than what it actually is or was. (Hockett, describing NYC Spring 2020 event)

**Structural Deep Event (Peter Dale Scott):** a mysterious, high-impact event – either instigated or exploited -- often involving lawbreaking, violence, intelligence networks, or hidden actors that disrupts the social order and is used, triggered, or exploited to advance major political-economic agendas. Examples: JFK Assassination, 9/11

**State Crime Against Democracy** (Lance deHaven-Smith, Matthew Witt): Illegal or anti-democratic actions or inactions by public officials or state-connected actors intended to subvert democratic processes, popular sovereignty, and public accountability. Examples: Watergate, Iran-Contra Affair

# Hockett #2

## Taxonomy and nomenclature

### Constructed Event

- *COVID-19 was (is) a constructed event that involved staging the sudden spread of a novel risk-additive disease-causing pathogen from a point source through simulated activities, actors, performances, and scripts. (Hockett)*

**(working definition, Watt/Hockett)** An event that occurs, but whose publicly-assigned cause is false or misleading. Government, media, and allied institutions attribute the event to one agent, force, or process while concealing, obscuring, or protecting causes (actual, alleged, or presumed), actors, or mechanisms.

- The goal is immediate and ongoing compliance/conformity: to induce people to accept the official/state-sponsored explanation, support or tolerate the prescribed response, refrain from resistance, and stop asking questions.
- A constructed event produces a *managed* understanding of what happened, who or what is to blame, and what must now be done.

# Watt #1

## **Journalism and Advertising** - broadcast, digital and print media

- There is no good evidence to support the belief that public health officers, government and corporate officers (“official sources”), editors, journalists or advertisers function with obligations to uphold ethical integrity standards, or are legally and financially incentivized to verify scientific and biomedical claims presented to public viewers and readers.
- Sources, reporters, advertisers and editors are under no legal obligation to assess the truth or falsity of factual claims, to refrain from presenting false information, or to only present true information.
- Evidence supports conclusion that editors, journalists and advertisers are legally and financially incentivized to present demonstrably false and distorted information as if it is true, and to suppress true information.

# Hockett #1

## **Controlled Opposition (dissent permitted by those in power) / Narrative Management**

- In the mainstream/alt/social media landscape, it is near-impossible for an individual who possesses any kind of skill to be elevated or promoted or permitted to have any kind of audience without the person being “managed”/attempted-managed in some way.
- Narrative Management is complex, multi-faceted, takes many forms and is exercised by many “sides”. (Use of cells, groups, networks, organizations, petitions, broadcasts...)
- State-Sponsored Narrative versus Dissident Narrative is a false dichotomy.
- Things that are *not* being said are as important, if not more important, than things that *are* being said.

How does what we've learned apply to the

# Alarm Bells: Hockett

## What I Noticed Right Away

### **Familiar, time-tested motifs**

- Ship: slow transportation mode (easier to control and draw attention to than planes & airports), captive group, int'l and domestic laws that “govern” quarantine
- *Virus from afar...*

### **COVID Analogues**

- *Diamond Princess, Grand Princess, USS Roosevelt*

### **Tools**

- Testing: Decisions had to be made about what to test for
- Legacy “elite” media coverage, e.g., *New York Times, Wall Street Journal*

### **Signals in official performances & scripts**

- Example: 1<sup>st</sup> WHO press conference - “mention” of Andean strain said to be transmissible between humans, “knowns” and “unknowns,” certainty about things that are far from certain, “soft” questions from approved reporters

## Possible hantavirus exposure from passengers leaving cruise ship

# Alarm Bells: Watt

- 2020–2025: Gained knowledge of construction of playbook or script used methodically by malicious political actors for many decades; pattern recognition, key elements of script.
- As a result: any announcement of “outbreak” of putative communicable disease, “emergence” of putative pathogen , “development” of putative immunization is an announcement of another performance of same old play being presented by government officers, journalists, advertisers, corporate officers, UN-WHO, Gates Foundation, GAVI, CEPI, etc.

# Recommendations for outbreak-theatre response.

- Don't be afraid.
- Don't participate (read, listen or watch) in outbreak-theatre advertisements, performances, reports or reviews by taking them seriously.
- Alt: Ignore, deride, false/constructed narratives, and educate others about the falsity and absurdity of the performance/threat projection.
- Don't isolate. Don't change your daily routines. Don't avoid or cancel special events or travel plans.
- Don't get into fights about outbreak-theatre with family and friends.
- Don't mask.
- Don't take so-called diagnostic tests.
- Don't engage in contact tracing or epidemiological surveillance.
- Don't take drugs or vaccines.
- When you get sick: rest, drink plenty of fluids, be patient, and let the illness run its course to recovery.

# Closing Thoughts

One of the things the government-corporate-media information-distortion and information-suppression system is built to do is make it harder for people to discuss things carefully with other people and realize that **many people are seeing the same absurd, non-sensical, foundationless things from different vantage points.**

- Discuss things carefully with other people.
- Understand that information provided by government-corporate-media sources is absurd, non-sensical and foundationless.
